In accordance with the provisions of Sub-Clause 8.1 of the Conditions of Contract, following the issue of the Letter of Acceptance, you are hereby given notice that the Commencement Date shall be **15 December 2017**


Pursuant to Sub-Clause 8.1 of the GCC we confirm that the precedent conditions for the issue of this Notice have been fulfilled namely:

- (a) The Contract Agreement has been signed by both Parties and approval of the Contract by the relevant Authorities has been issued;
- (b) Delivery to the Contractor of reasonable evidence of the Employer's Financial arrangements (under Sub-Clause 2.4 [*Employer's Financial Arrangements*]) has been carried out;
- (c) Effective access to and possession of the Site has been given to the Contractor together with such permission under (a) of Sub-Clause 1.13 [*Compliance with Laws*] of the GCC as required for the commencement of the Works; and
- (d) Receipt by the Contractor of the Advance Payment under Sub-Clause 14.2 [*Advance Payment*] and that the corresponding bank guarantee has been delivered by the Contractor.

You are requested therefore to commence the execution of the Works with due expedition and without delay.

You are also reminded of your obligations pursuant to Sub-Clause 18.1 of the General Conditions and the Particular Conditions that you shall provide evidence to the Employer within 14 days of the Commencement Date that the insurances required under the Contract have been effected. Please therefore submit the requisite evidence of insurances prior to the commencement of any physical activities on site.
